

## DHHS Document: COVID-19 Guidance for Health Care Providers

On May 12, the Director (Dr. Redfield) of the U.S. Centers for Disease Control and Prevention (CDC) stated that CDC is in the process of updating its April 27 guidance on dental services which recommends postponing non-urgent dental care. Once issued, Maine Department of Health and Human Services (DHHS) will rely upon it along with relevant guidance from the American Dental Association (ADA) and Maine Dental Association (MDA).

## CDC Guidance (May 12):

- "As the pandemic continues, healthcare systems must balance the need to provide necessary services while minimizing risk to patients and healthcare personnel."
- "It is unknown at this time how COVID-19 may permanently change infection control
  practices in dental health care settings, but CDC continually assesses emerging
  scientific evidence for developing policies, guidelines, and recommendations."
- "Dental health care personnel are licensed by their <u>state regulatory body</u> and should practice according to their state dental practice acts or other relevant regulations.
   CDC is not a <u>regulatory agency</u> and does not publish regulations or other legally enforceable standards related to infection prevention and control in dental health care settings."





#### What Masks Do We Use?



- N95
  - Initial fit test / Respiratory Protection Plan (RPP)
  - RPP: <a href="https://www.cdc.gov/niosh/docs/2015-117/default.html">https://www.cdc.gov/niosh/docs/2015-117/default.html</a>
- KN95 (<a href="https://www.fda.gov/media/136663/download">https://www.fda.gov/media/136663/download</a>)
  - All respirators must be tight-fitting to be superior to surgical masks
- FDA approved level 3
  - During an aerosol generating procedure, a face shield should be used with this type of mask (MDA).
- Non-clinical staff 1, 2, 3 (barriers and/or face covering)

## Goggles/ Eye Wear/ Face Shields:

- According to ADA: Goggles are the protection glasses normally used by the professional during routine procedures. They must protect the eyes and have a side shield.
- Currently, ADA recommends either goggles or face shield.

## What is meant by gowns?

 Surgical gowns or isolation gowns may be disposable. They are long sleeve and have a layer of polypropylene that makes them impermeable. The most effective kind close in the back.

 If a cloth gown is to be worn, they must also have long sleeves. It must be removed while in the office and either laundered in the office or in a commercial laundry facility.

Q: Can I reuse a cloth gown?

**A:** Yes. Cloth gowns that will not be used in a sterile field, such as surgery, can be reused if they are laundered in enzymatic detergent or per the hospital's SOP.

## Air Quality - What should I do?

- This depends on each individual office.
- Research about air quality and the potential for SARS-CoV-2 to act opportunistically as an aerosolized virus is mixed. There is no current standard for air quality in dental health care facilities. As such, dentists should employ one or a combination of the following: HEPA filtration/supplemental evacuation/Ultraviolet disinfection/allowing additional time between patients.
- We recommend you make a plan and make it known to your team.

## Do I need to have less than 10 people?

- This state requirement is for "gatherings," not for health care settings.
- Use social distancing or face coverings.
- Consider virtual waiting room.

## Ways to Ease Team Tension:



- Equip the team with the best PPE you can source. If there is trouble sourcing PPE, tell them. Ask for their help in searching for PPE.
- Give them extra time for their procedures and all other tasks.
- Communicate with them to let them know the challenges we face from an economic standpoint.
- Ask what each team member is most concerned about and talk through how to address those concerns.
